Complete all fields on Application

All boxes must be completed in the Credit Application paperwork, or you should insert "n/a" (not applicable). Print legibly to minimize delays. Be sure you read, understand, and sign the individual continuing guarantee.

Credit Card Billing

All payments must be made on time. If any payments are late we will charge your credit card when invoices are delinquent. Our Credit Card Billing Authorization is very important. Any boxes left blank in the authorization will automatically disqualify you. After the initial payment for the deposit, your credit card will be run automatically on the first day that any invoice becomes delinquent.

Insurance

Lessee or Renters are required to provide a certificate of insurance showing liability insurance with a \$1,000,000.00 limit and physical damage insurance for the value of the equipment naming Atlantic Utility Trailer Sales, Inc. (AUTS) as additional insured and loss payee per the terms & conditions of the lease agreement.

Lessee is responsible additionally for the liability or any claim to the contents or products contained therein arising out of the failure of the refrigeration machine and/or trailer regardless of the cause of such failure and therefore lessee is required to obtain at the lessee's sole cost and expense cargo insurance.

Maintenance & Repairs

If your agreement includes full maintenance, then Atlantic Utility Trailer Sales provides 24/7 breakdown service. When you rent or lease a trailer you are required to contact us prior to having any repairs made. We have a nationwide network of repair vendors that we work with to expedite repairs and minimize downtime. **Any repairs completed without contacting us and receiving authorization will not be paid for by Atlantic Utility Trailer Sales, Inc.**

To minimize the occurrence of breakdowns it is your responsibility to help us meet the PM schedules for both trailer and reefer units. When equipment is due for periodic maintenance it is preferred that you bring the trailer to our Thorofare, NJ location to have the maintenance or repairs made. If you will not be in our area when PM's are due you can call our service department to make arrangements to schedule the work at another site. When the equipment is in our immediate service area we may be able to send our mobile service trucks to perform the PM. Outside of our primary service area we can schedule the work with another vendor.

During regular business hours, call our Service Department to schedule maintenance or for breakdown service at **(856)384-7800**. After hours call the same number for emergency breakdown service and select option #4 when the automated attendant answers to be connected to our answering service. They will then contact the on-call representative who will promptly return your call.

Customer is responsible for checking and maintaining all fluid levels, including, but not limited to, reefer fuel level, reefer engine oil, reefer unit coolant level, axle hub oil levels, etc. Failure to properly maintain and check fluid levels may result in repair and service expenses being billed to customer. AUTS will check and refill fluid levels (other than reefer fuel) when we perform maintenance or service on the equipment.

Tire Policy

Normal wear on tires is included in the maintenance charges on the rental or lease agreement. However, Road Hazard, excessive wear, or damage (flat spots, irregular wear, sidewall impacts, etc.) is not covered. If tires are replaced on the road and it is determined that replacement was required for any reason other than normal wear and tear, then the cost of the replacement and any other associated repairs will be billed to your account and due in full. In the event that a trailer is returned with excessive wear or tires that are not the same or better quality than what was provided on the trailer when picked up, as identified on the initial outbound inspection, a fee to recover the loss in value will be assessed and immediately payable. The fee will be assessed at \$40/32nd of tread wear and charged to your account.

Remote Unit Disable

Many of our units are equipped with a device that allows us to track the equipment and disable the refrigeration unit remotely. If you fail to make timely payments, **YOU** authorize us to shut down the reefer unit and fully indemnify and hold us harmless for any damage or claims that may result. (Please read the Rental Agreement in its entirety and make sure you understand it.)

Tax Exemption

If applicable, it helps make things quicker if you fill out in advance the Sales Tax-Exempt Use Certificate (ST-04). Without a certificate on file you will be charged Sales Tax on all transactions.

If a first line tire is replaced with a recapped tire a fee to recover the casing value may apply. Tires should be replaced between 2/32" and 4/32" of tread remaining. If tires are run below 2/32" of tread remaining a fee to recover any damage to the casing may apply.

Tire wear not covered by maintenance contract is billed at \$40 per 32nd".
